Brief summary related to work:

- Nirman Development Society, Ranchi implemented the project of water, Sanitation and Health in Simdega, where the agency Constructed Individual Households Toilet and arranged the information dissemination workshops at community level with the beneficiaries. The work has been completed in 2010-11 in Bolwa block of Simdega under District Water and Sanitation Mission, Simdega. The work was done under the PRAKALP Society of Govt where Total Sanitation Campaign/Swajaldhara and School water Supply Sanitation and hygiene education were envisaged.
 - Nirman Development Society, Ranchi worked under SCA to TSP (Prototype Project) in Saraikela Kharsawan in 2012 for construction of irrigation Tank for promotion of livelihood to farmers.
 - Nirman Development Society, Ranchi implemented the project “Promotion of vegetable cluster with inter cropping along with Drip Irrigation with 550 HHS in 11 villages of Simdega with ITDA, Simdega under SCA to TSP in 2020.
